

ORDER OF FORMAL PROBATE OF
WILL AND FORMAL APPOINTMENT
OF PERSONAL REPRESENTATIVE

The Petition for Formal Probate of Will and Formal Appointment of Personal Representative, signed by Thomas E. Juckel, came before the Honorable James E. Dehn, Judge of District Court on March 18, 2014. After considering the petition, the Court makes the following findings:

1. **Petition and Verification.** The petition is complete. The petitioner has made oath or affirmation that the statements contained in the petition are true to the best of the petitioner's knowledge and belief.
2. **Information about the Decedent's Domicile.** At the time of death, the decedent was domiciled in the County of Isanti, State of Minnesota, at 32281 Highway 47 NW, Cambridge, Minnesota 55008.
3. **Interest of Petitioner.** The petitioner appears from the petition to be an interested person as defined by Minnesota law.
4. **Venue.** Based on the statements in the petition, venue in Isanti County is proper.
5. **Notice.** Any notice required by Minnesota law has been given.
6. **Testamentary Documents.** The decedent's last Will is comprised of the following documents: *(check all that apply)*

- Will dated October 15, 2010
- Codicil dated [Codicil Date]
- Separate Writing under Minn. Stat. § 524.2-513 dated [Separate Writing Date]
- a Separate Writing identified in the Will that has not been located.

7. **Location or Disposition of Testamentary Documents.** *(check only one)*

- The original documents constituting of the decedent's Will are in the Court's possession.
- An authenticated copy of the decedent's Will, as probated in [Other Jurisdiction], accompanied the petition and is in the Court's possession.

8. **Decedent's Death.** The decedent died on December 30, 2013. Petitioner commenced this proceeding within the time limitations prescribed by Minnesota law.

9. **Survival of Heirs.** All persons identified as heirs have survived the decedent by at least 120 hours. *(check appropriate boxes)*

The decedent left no surviving spouse.

The decedent left no surviving issue.

All issue of the decedent are issue of the decedent's deceased spouse.

There are issue of the decedent and/or the decedent's surviving spouse who are not issue of both the decedent and decedent's surviving spouse.

10. **Information about the Personal Representative.** Thomas E. Juckel, seeks appointment as personal representative. From the statements in the petition, Thomas E. Juckel has a priority entitlement to the appointment, has not been disqualified, and has not renounced appointment.

The petition indicates that no personal representative has been appointed in another county of Minnesota whose appointment has not been terminated.

11. **Administration.** The decedent's Will: *(check only one)*

specifies that the administration of the decedent's estate is to be supervised.

12. **Bond.** The decedent's Will: *(check only one)*

13. **Determination of Heirs.** The decedent's heirs under Minnesota law are as identified in the petition.

14. **Objections.** There are objections to the petition. Steven P. Juckel filed a Petition for Formal and Supervised Estate Proceeding and Demand for Bond. Steven P. Juckel objects to Thomas E. Juckel proceeding unsupervised and requests that a bond be posted. The petition of Steven P. Juckel was not filed in accordance with Minn. Stat. §524.3-502. The Court finds no basis to order supervised administration of the estate.

IT IS ORDERED:

1. The petition of Thomas E. Juckel is granted. The petition of Steven P. Juckel is denied.
2. The decedent's Will is formally probated.
3. The decedent's heirs under Minnesota law are as identified in the petition.
4. Thomas E. Juckel is formally appointed as the personal representative of the decedent's estate, with no bond in an unsupervised administration.
5. Letters Testamentary will issue after Thomas E. Juckel files a statement of acceptance and oath and posts any required bond.
