The East 100 feet of the West 320 feet of Government Lot 5, Section 21, Township 48, Range 24, subject to easement for roadway as now located across the above land; AND The East 80 feet of the West 120 feet of Government Lot 5, Section 21, Township 48, Range 24, subject to easement for roadway as now located across the above land; AND The East 100 feet of the West 220 feet of Government Lot 5, Section 21, Township 48, Range 24, subject to roadway across said property; AND All that part of Government Lot 5, Section 21, Township 48, Range 24, described as follows: Commencing at the southwest corner of said Lot 5 and running thence east along the south line thereof a distance of 320 feet, thence North to a point 100 feet south of the shore of Rock Lake, the point of beginning of the track hereby described; thence North to the shore of Rock Lake; thence Southeasterly along said shoreline to a point east of the point of beginning; thence West to the point of beginning; EXCEPTING AND NOT INCLUDING That portion of said Government Lot 5, Section 21, Township 48, Range 24, described as follows: Commencing at the southwest corner of said Lot 5 and running thence East 120 feet; thence North 450 feet to the point of beginning; thence East 75 feet; thence North to the shore of Rock Lake; thence northwesterly along said shore line to a point north of the point of beginning; thence South to the point of beginning; All of the above being subject to mineral reservations and easements of record if any.

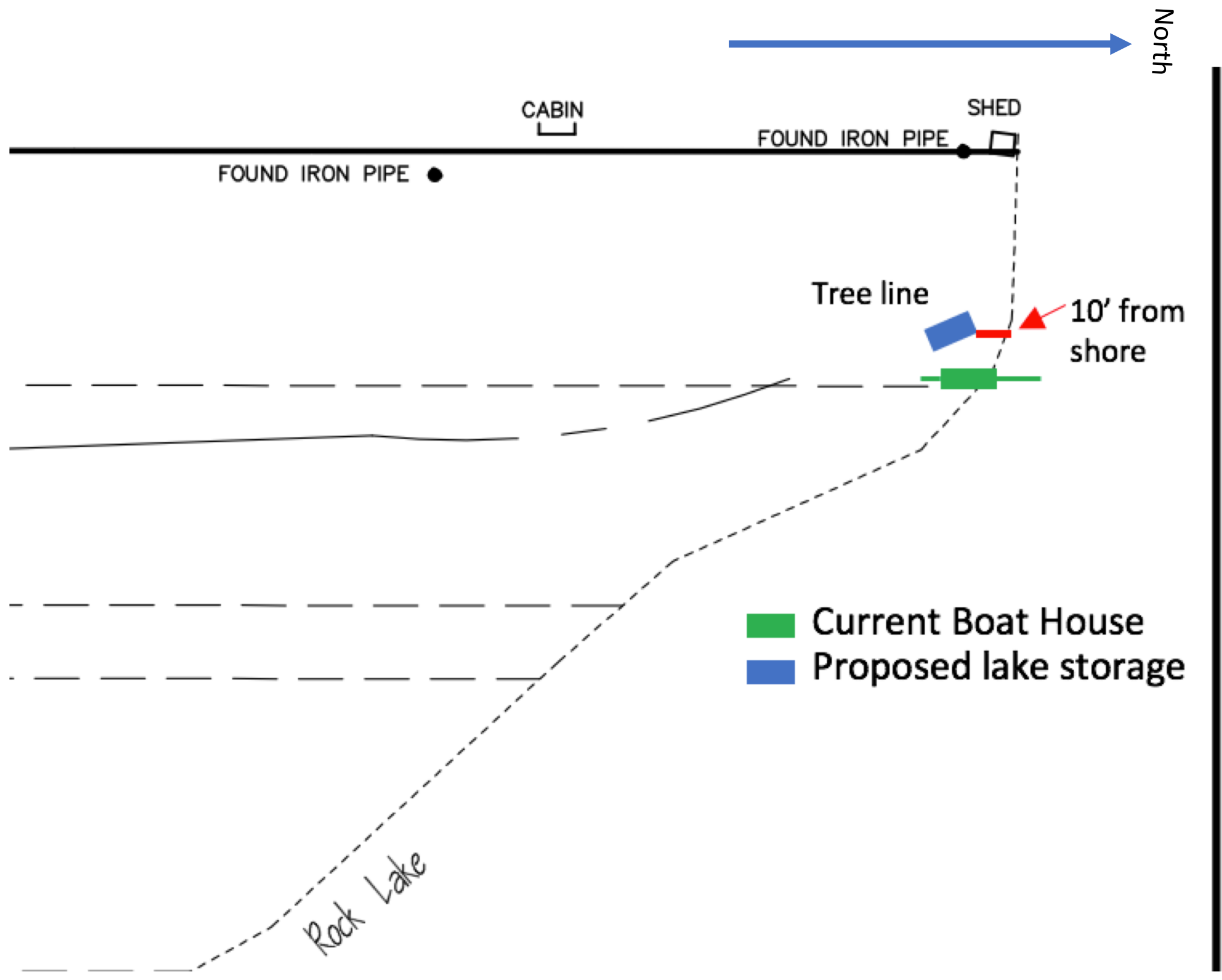

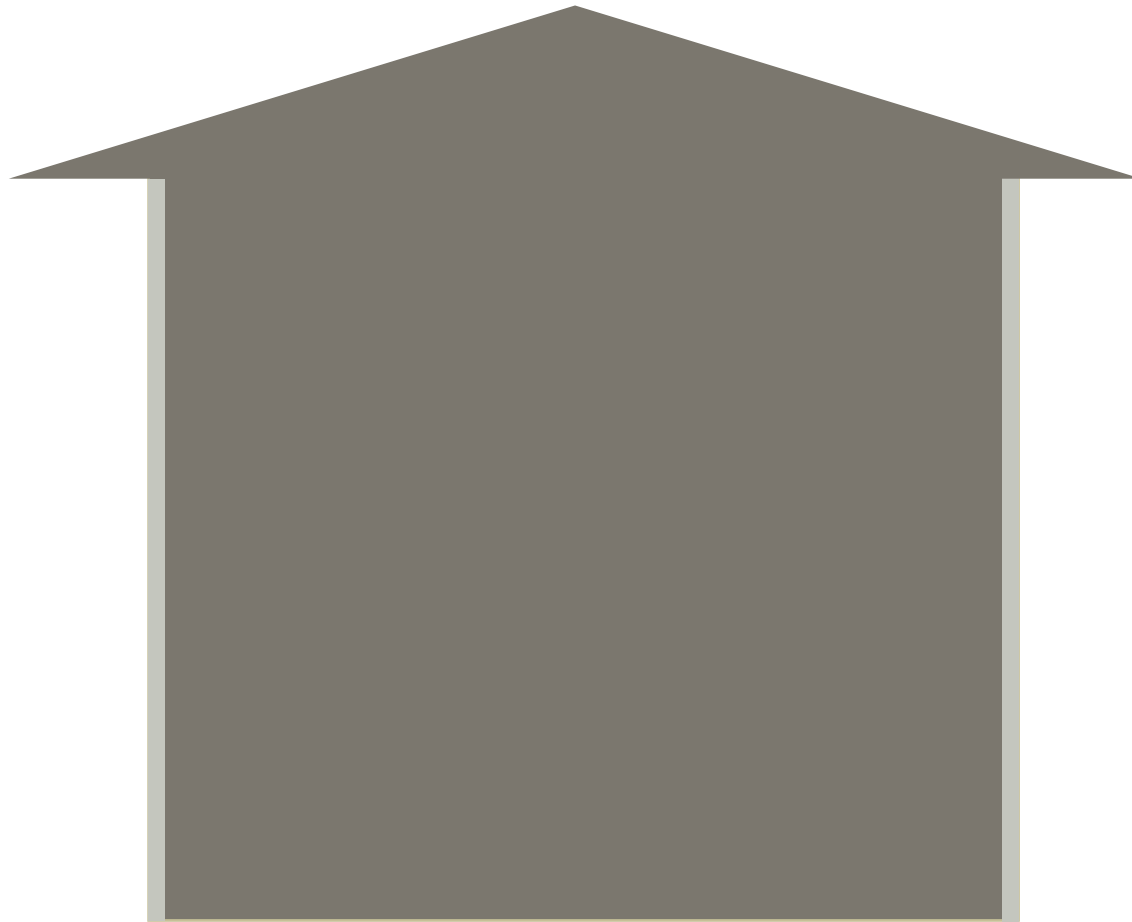

South East side – Facing road coming down from cabin

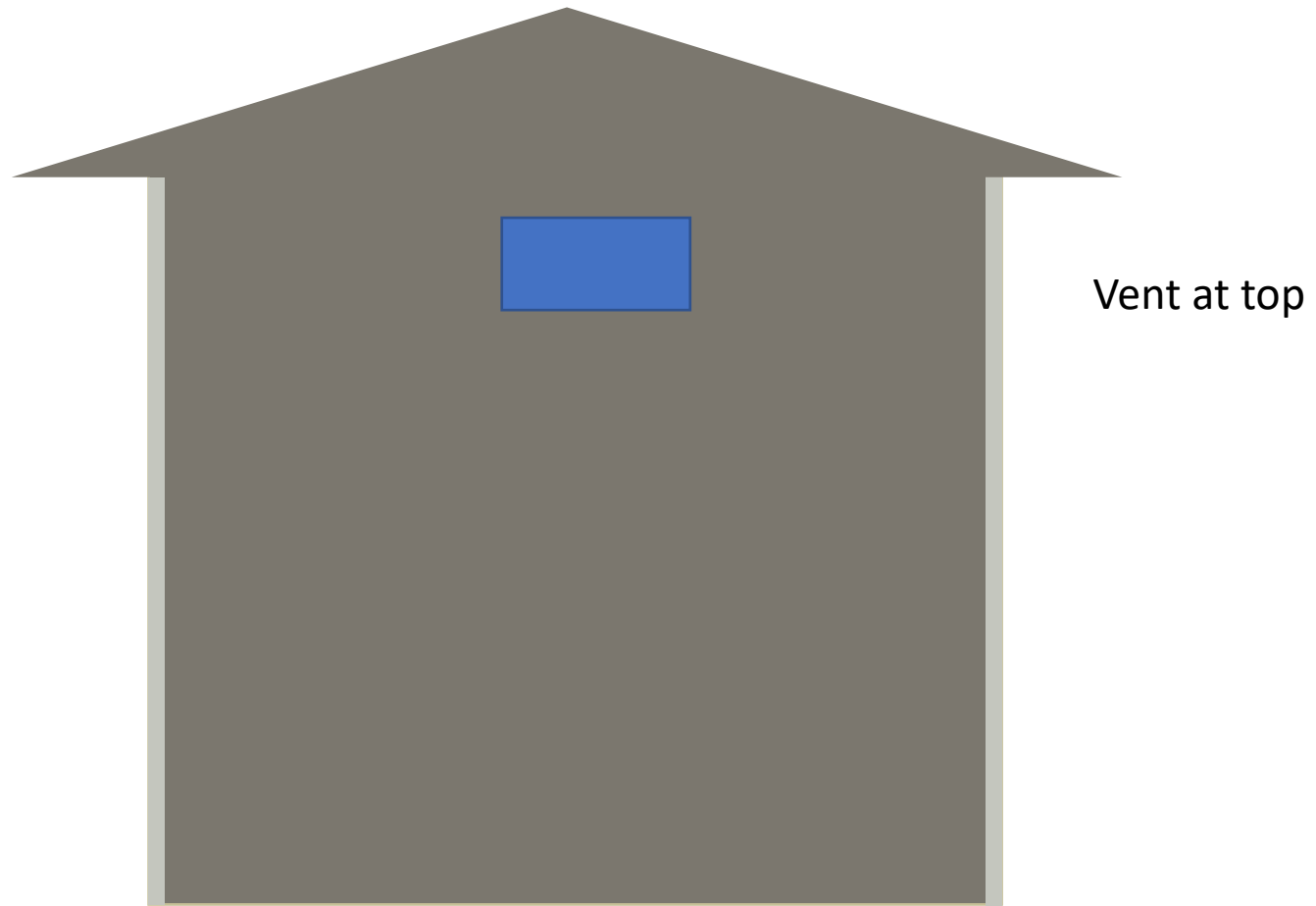
