
CERTIFICATE OF SURVEY

PROPOSED LEGAL DESCRIPTIONS:

PARCEL A:

Range 26, Aitkin County, Minnesota described as follows: Commencing at the Southwest corner of the Southeast Quarter of said Section 22; thence on

Quarter of the Southeast Quarter and also being the Point of Beginning of the land herein described; thence South 89 degrees 59 minutes 24 seconds East along last said line a distance of 1323.69 feet to the East line of said Northwest Quarter of the Southeast Quarter; thence North 00 degrees 36 minutes 39 seconds East along last said line a distance of 79.57 feet; thence South 88 degrees 37 minutes 55 seconds West, 1324.43 feet to the Wes line of said Southeast Quarter; thence South 00 degrees 34 minutes 52 seconds West along last said line a distance of 47.71 feet to the Point of beginning.

PARCEL B:

Range 26, Aitkin County, Minnesota described as follows: Commencing at the Southwest corner of the Southeast Quarter of said Section 22; thence on an assumed bearing of North 00 degrees 34 minutes 52 seconds East along the West line of said Southeast Quarter a distance of 1346.90 feet to the South line of the Northwest Quarter of the Southeast Quarter of said Section 22; thence South 89 degrees 59 minutes 24 seconds East along last said line a distance of 1323.69 feet to the West line of said Northeast Quarter of the Southeast Quarter and also being the Point of Beginning; thence North 00 degrees 36 minutes 39 seconds East along last said line a distance of 79.57 feet; thence North 88 degrees 37 minutes 55 seconds East, 99.22 feet; thence South 00 degrees 34 minutes 33 seconds West, 81.95 feet to the South line of said Northeast Quarter of the Southeast Quarter; thence North 89 degrees 59 minutes 24 seconds West along last said line a distance of 99.22 feet to the Point of Beginning.

PARCEL C: That part of the Southeast Quarter of the Southeast Quarter of Section 22, Township 48, Range 26, Aitkin County, Minnesota described as follows:

an assumed bearing of South 89 degrees 11 minutes 10 seconds East along the South line of the Southeast Quarter of said Section 22 a distance of 1322.93 feet to the West line of said Southeast Quarter of the Southeast Quarter and also being the Point of Beginning of the land herein described; thence North 00 degrees 36 minutes 39 seconds East along last said line a distance of 1365.47 feet to the North line of said Southeast Quarter of the Southeast Quarter; thence South 89 degrees 59 minutes 24 seconds East along last said line a distance of 99.22 feet; thence South 00 degrees 34 minutes 33 seconds West, 1366.86 feet to the South line of said Southeast Quarter of the Southeast Quarter; thence North 89 degrees 11 minutes 10 seconds West along last said line a distance of 100.04 feet to the Point of Beginning.

PARCEL D:

Range 26, Aitkin County, Minnesota described as follows: Commencing at the Southwest corner of the Southeast Quarter of said Section 22; thence on an assumed bearing of South 89 degrees 11 minutes 10 seconds East along the South line of the Southeast Quarter of said Section 22 a distance of 1322.93 feet to the West line of said Northeast Quarter of the Northeast Quarter and also being the Point of Beginning of the land herein described; thence South 00 degrees 41 minutes 26 seconds West, 1270.78 feet to the South line of said Northeast Quarter of the Northeast Quarter; thence North 89 degrees 49 minutes 00 seconds East along last said line a distance of 100.16 feet; thence North 00 degrees 41 minutes 09 seconds East, 1269.03 feet to the North line of said Northeast Quarter of the Northeast Quarter; thence North 89 degrees 11 minutes 10 seconds West along last said line a distance of 100.04 feet to the Point of Beginning.

PARCEL E: That part of Government Lot 3, Section 22, Township 48, Range 26, Aitkin County, Minnesota lying South of the following described line: Commencing at the Southwest corner of the Southeast Quarter of said Section 22; thence on an assumed bearing of North 00 degrees 34 minutes 52 seconds West line of said Southeast Quarter of said Section 22 a distance of 1394.61 feet to the Point of Beginning of the line herein described; thence North 89 degrees 28 minutes 17 seconds West, 939 feet more or less, to the easterly edge of the Mississippi River and there terminating.
